➤ Purchase price \$4.00 – July 1, 2023.

➤ Purchase price \$4.40 – July 1, 2024.

\* Presented Ordinance 23-13 for second read, Res 23-14 and Res 23-15 to Council.

**ORDINANCE 23-13:**

AN ORDINANCE AMENDING ORDINANCE 07-05

THIS ORDINANCE WILL GOVERN THE KEEPING OF CHICKENS WITHIN THE VILLAGE LIMITS AND IS DESIGNED TO LIMIT NUISANCES AND PREVENT UNSANITARY OR UNSAFE CONDITIONS. THIS ORDINANCE ALSO PROHIBITS THE RAISING, KEEPING, MAINTAINING, OR HARBORING OF LIVESTOCK OR OTHER FOWL, EXCLUDING CHICKENS (LAYING HENS) WITHIN THE VILLAGE LIMITS was presented to Council Joe Williams made a motion to move Ordinance 23-13 to the third reading, seconded by Scott Moore. Roll call vote, all yeas.

**RESOLUTION 23-14:**

**A RESOLUTION ALLOWING THE FISCAL OFFICER VACATION, HOLIDAYS AND PERSONAL DAYS** was presented to council. A motion to adopt **Resolution 23-14** was made by Joe Williams, seconded by Jamie White. Roll call vote, all yeas.

**RESOLUTION 23-15:**

**A RESOLUTION AUTHORIZING THE MAYOR TO ACCEPT THE LOWEST BID FOR THE NEW MANLY PARK CONSTRUCTION.** A motion to adopt **Resolution 23-15** was made by Jamie White, seconded by Don Larrick. Roll call vote, all yeas.

**Bill Smith, Village Administrator gave the following report:**

- \* River bank has been cleared.
- \* Need a couple more signs for kayak ramp.
- \* To meet with Rent Fun Kayak's on the 27<sup>th</sup>.
- \* Approached by a couple people wanting to rent dock space.
- \* Curbs are being cleaned for painting.
- \* Water line break on Mill Street.

**Council Member, Homer Weekley:**

- \* Renting dock space – A committee consisting of Don Larrick, Leslie Robbins and Jamie White to meet and discuss rentals.

**Council Member, Leslie Robbins:**

- \* Vehicle on 11<sup>th</sup> Street and Echo Street has two flat tires and no license plates.
- \* Trees as tall as 60' leaning on electric wires.
- \* Legion has been contacted about putting hometown hero's on poles.
- \* Talk with Darren Little, from the Cat dealership in Zanesville, he gave me his card.
- \* Received a text from the Cemetery Committee asking who is to sign off for AEP.

**Council Member, Jamie White.:**

**Council Member, Scott Moore**

- \* Term is up from Council after December 31<sup>st</sup>, 2023


**Council Member, Don Larrick:**
