

## **ORDINANCE 23-07**

### **AN ORDINANCE DECLARING SURPLUS PROPERTY AND AUTHORIZING THE MAYOR TO ADVERTISE FOR BIDS AND SELL TO THE HIGHEST BIDDER.**

**WHEREAS**, the Council of the Village of Malta has deemed it necessary to sell the following equipment in order to purchase new equipment. Kobota with bucket and hoe, 2005 GMC Dump Truck, 2004 Backhoe with two hoe buckets, 2000GMC 2500 4x4 extended cab, 2015 Dodge Ram 5500 Cummins with Aluminum Dump Bed, 9 Ft Western Pro Plus Plow and Salt Spreader, Swenson Hydraulic Salt Spreader, 3 Point Post Hole Digger with 12-inch Bit, 6 Foot 3 Point Blade, Woods MD160 Brush Hog and Versa Link 405 Printer

**NOW THEREFORE BE IT ORDAINED** by the Council of the Village of Malta, County of Morgan, State of Ohio, that:

**Section 1:** The Kobota with bucket and hoe (**with Reserve**), 2005 GMC Dump Truck (**with Reserve**), 2004 Backhoe with two hoe buckets (**with Reserve**), 2000 GMC 2500 4x4 extended cab (**with Reserve**), 2015 Dodge Ram 5500 Cummins with Aluminum Dump Bed, 9 Ft Western Pro Plus Plow and Salt Spreader (**with Reserve**), Swenson Hydraulic Salt Spreader, 3 Point Post Hole Digger with 12-inch Bit, 6 Foot 3 Point Blade, Woods MD160 Brush Hog and Versa Link 405 Printer, are hereby declared to be surplus property which serves no governmental purpose or need;

**Section 2:** The Mayor and the Village Administrator are hereby authorized to advertise the sale of the following equipment by sealed bids.


- 1 Kobota with bucket and hoe (**with Reserve \$8,475.00**)

- 1 2004 Backhoe with two hoe buckets (**with Reserve, \$22,500.00**)
- 1 2000 GMC 2500 4x4 extended cab (**with Reserve, \$2,250.00**)
- 1 2015 Dodge Ram 5500 Cummins with Aluminum Dump Bed, 9 Ft Western Pro Plus Plow and Salt Spreader (**with Reserve, \$60,000**)
- 1 Swenson Hydraulic Salt Spreader, 3 Point Post Hole Digger with 12-inch Bit
- 1 6 Foot 3 Point Blade
- 1 Woods MD160 Brush Hog
- 1 Versa Link 405 Printer



**Section 5:** That it is hereby found and determined that all formal actions of the Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of the Council and that all deliberations of the Council and any of the decision making bodies of the Village of Malta which resulted in such formal actions were in meeting open to the public in compliance with all legal requirements of the Village of Malta, Morgan County, Ohio.
