WHEREAS, the Village of MALTA is situated within the geographic boundaries of the Southeastern Ohio Joint Solid Waste Management District (the District); and

WHEREAS, the Policy Committee for the District adopted a draft Solid Waste Management Plan on March 6th, 2023, for the fifteen-year period beginning in 2024 and ending in 2038; and

WHEREAS, the draft Solid Waste Management Plan for the District was submitted to council for its review in accordance with the requirements of Chapters 343 and 3734 of the Ohio Revised Code;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF MALTA : that, the draft Solid Waste Management plan for the Southeastern Ohio Joint Solid Waste Management District is hereby ratified; and

**POLICY ADVISORY COMMITTEE

The policy Advisory committee of the Southeastern Ohio Joint Solid Waste Management District met in regular session on March 6, 2023. Upon motion by Mr. Reiter, seconded by Ms Crooks the Committee considered the following resolution

**A RESOLUTION OF THE POLICY ADVISORY COMMITTEE
TO ADOPT THE DRAFT SOLID WASTE MANAGEMENT
PLAN AND FORWARD THE PLAN FOR RATIFICATION**

WHEREAS, the Southeastern Ohio Joint Solid Waste Management District Plan was approved by the Director of Environmental Protection in April of 2017; and

WHEREAS, the approved plan must be reviewed and revised after five years, and resubmitted to the Director of Environmental Protection for comment; and

WHEREAS, a revised plan, assuring capacity for the fifteen year period commencing in 2024 and ending in 2038 has been developed by the Committee; and

WHEREAS, notice of a revised plan was published in newspapers of general circulation within the District and a 30-day public comment period was established; and

WHEREAS, the fifty largest generators of solid waste within the District were notified in writing of the availability of the revised-draft solid waste management plan for review during the 30-day public comment period; and

WHEREAS, within 15 days of the completion of the public comment period, on March 6, 2023, a public hearing was held to solicit additional comments from the public; and

WHEREAS, the Policy Committee has considered the comments submitted during the comment period and at the public hearing meeting;

NOW THEREFORE, be it resolved by the Policy Committee of the Southeastern Ohio Joint Solid Waste Management District, that:

Section 1. This Committee hereby adopts the draft plan.

Section 2. The District Coordinator is further authorized to secure the services necessary to print sufficient copies of the plan and deliver a separate copy of the plan to each political subdivision within the District, including each Board of County Commissioners, City or Village Council, and Board of Township Trustees, and to request each political subdivision to adopt a resolution ratifying the draft plan.
